## **Course Chinese Feed import legislation (feed additives, premix, milkreplacer and Petfood)**

Since 2009 the Chinese authorities have strict import legislation for feed and feed additives (AQSIQ 2009/118). Part of this legislation is the requirement that companies exporting to China need to be aware of the Chinese import legislation of feed, as well as the Chinese standards for safe feed production. During recent meetings with officials of the Chinese authorities GACC, it was observed that exporting companies were not aware enough of the legislation.

This webinar, which will be presented by CCIC and Way2Trade, in close contact with GACC, will guide you through the basic principles of the Chinese feed, feed additives and premix, and Petfood legislation.

### **The course**

The webinar will be organized on May 18<sup>th</sup> 2021, from 13.30 till 16.30 hrs

In the first part mr. Den Hollander, director of Way2Trade will guide you through the veterinary import legislation in China with an European perspective. In the second part CCIC will guide you through the production and feed safety legislation in the PR China.

The webinar is a combined course for feed/calf milk replacer, feed additives, premix and petfood. The course will be held in English language.

There is a limited number of participants (max. 20 persons).

The participants of the course will receive a certificate of CCIC about participating in this knowledge exchange, which can be used during future inspections by GACC.
