# **Online course China organic**



Are you willing to export meat, food products, dairy or feed and Petfood to China which is organic? If yes, please note that organic production in Europe is not equal to organic production in China. The certification of products to be sold in China as organic can also be done in Europe. Production plants will need detailed knowledge on the differences between Europe and China. This course will train you how to deal with the Chinese organic legislation and is focused on animal feed, Petfood, meat, dairy, and fruits/plants.

Organic products need to be certified as China Organic in order to be allowed to be imported, marketed, and sold as *Organic Products* in China. Products that have only EU organic, US organic, etc. are NOT allowed to be treated as organic products in China.

Only accredited certification bodies may carry out organic inspection and issue China organic certificates for products. These certification bodies follow complex requirement in order to determine if a product can be certified as organic:

- Requirements of the Certification and Accreditation Administration of the People's Republic of China (CNCA)
- Requirements of the China National Standards GB/T 19630
- The own rules set by the certification bodies themselves

In addition, the new version of GB/T 19630-2019 was recently implemented (starting on 1-1-2020) which has changes compared to the old version, but in how it was structured and its content.

This course is developed by CCIC and Way2Trade and provides detailed knowledge in the China Organic field for all European organic producers to help them understand:

- The regulatory background of China organic.
- Differences between China organic and EU organic.
- How to obtain the China organic certificate.
- Important things to consider when preparing the application or during organic inspections.

CCIC is the parent organization of China Quality Certification Centre (CQC), which is the largest

certification body in China and has excellent internal source of knowledge about China Organic Certification.

CCIC Europe have own China Organic Certification auditors who can speak fluent English and has years of experience independently carrying out China Organic Certification audits in Europe. This means that we have personnel located in Europe to provide training.

CCIC Europe has recently carried out internal review and training on the newest update of the GB/T 19630 and also a comparison training between GB/T 19630 and EU organic. This means CCIC Europe possess the freshest information to share.

Way2Trade is a consultancy company, working on behalf of several branch organizations in the field of export to countries outside the European Union, with a specialization in China.

#### The course

The training consists:

- China Organic Regulation, mostly concerning the CNCA and the core principles.
- GB/T 19630, the core standard about of China Organic.
- GB/T 19630, and comparison between GB/T 19630 and EU organic requirements.
- The certification process in China, including core steps such as application, document requirement, on-site inspection, maintaining the certificate, etc.

There is a limited number of participants.

The participants of the course will receive a certificate of CCIC about participating in this knowledge exchange, which can be used during future inspections by GACC.
